1. INTRODUCTION:

Bharat Immunologicals & Biologicals Corp. Ltd. (BIBCOL), A Govt. of India Undertaking, under administrative control of Ministry of Science and Technology, located at village-Chola, Distt- Bulandshahr (UP), about 70Km away from Delhi at Old G.T. Road connecting Sikandrabad to Khurja, has been engaged in manufacturing Vaccine for the last twenty five years with contributing significantly in National Immunization Programme.

2. OBJECTIVE:

BIBCOL invites sealed tenders for the supply of **Monovalent Bulk of Poliomyelitis (Type-I and Type-III) from WHO prequalified Bulk manufacturers (Bio-Farma) as per Annexure 'A'**. **Authorized agents/distributor of manufacturer can participate in the tender.**

3. INSTRUCTION TO TENDERERS:

Tenders should be submitted in two parts separately in two sealed envelopes super scribed as Techno Commercial Bid and Price Bid respectively & two envelopes should be kept in large envelop duly super scribed as Bid for the **"Supply of Monovalent Bulk of Poliomyelitis – not to be opened before 25.04.2019 at 3.00 P.M.** on the left of top side of envelope addressed to **Associate Vice President (P), Bharat Immunologicals & Biologicals Corporation Limited (A Govt. of India Undertaking), Oral Polio Vaccine Plant, Village-Chola, Bulandshahr – 203001 (UP) INDIA**

4. TECHNICAL BID:

Techno Commercial bid should essentially consists: Name of company with complete address, type of establishment, name of contact person, list of current buyers in India and other than India with quantities supplied for last 03 years, production capacity, Annual Turnover, detailed technical specifications of the products and copy of Certificate of WHO GMP Pre-qualifications. **Authorized agent/ distributor has to provide the authority letter of the manufacturer, valid on the date of closing of tender and should be valid for the duration of supplies.**

5. PRICE BID:

Price Bid will essentially consists: Type wise price per litre, currency in which payment should be made of the products, freight charges, insurance charges and other terms and conditions etc. Credit period of payment through F.L.C., delivery period and other relevant financial details.

6. Techno-Commercial bid will be opened on the due date and price bid will be opened after evaluation of Techno Commercial Bid by the committee constituted by competent

authority. The date of opening of price bid will be separately communicated to successful bidders and the price bid of technically rejected party will not be opened.

Terms and conditions

1. The quantity mentioned is tentative and can increase or decrease. **BIBCOL shall enter into rate contract for purchase of bulk as per requirement.**
2. The supplies shall be made as per requirement in different lots.
3. There is no prescribed form for submission the quotation/offer. Bidder may use his own letter head.
4. **The quoted price of the products should be in CIF and transit insurance should be covered from supplier's ware house to our ware house i.e. OPV Plant, Village Chola, Bulandshahr-203001 (UP) INDIA. .**
5. Goods should be properly packed and labeled the name of product, name of manufacturer, batch No., Mfg. Date., Exp. Date etc.
6. No figures or words should be overwritten. Incorrect figures or words should be scored out and rewritten under your signatures.
7. You are at liberty to be present or authorize a representative to be present at the opening of the bids at the specified time and date.
8. BIBCOL reserves the right not to accept the lowest or any tender or part thereof without assigning any reason.
9. Quality & time are important aspects of supplies. BIBCOL may select more than one vender in case of critical and or large supplies. The L-2 vender may also be offered for some quantities based on L1 rate. However, the major portion of order shall be placed on L-1 party subject to meeting other terms and conditions.
